SURFACE PREPARATIONS

Use in accordance with the standard Worldwide Marine Specifications.

All surfaces to be coated should be clean, dry and free from contamination.

High pressure fresh water wash or fresh water wash, as appropriate, and remove all oil or grease, soluble contaminants and other foreign matter in accordance with SSPC-SP1 solvent cleaning.

NEWBUILDING

Where necessary, remove weld spatter and smooth weld seams and sharp edges.

This product must only be applied to surfaces prepared by abrasive blast cleaning to Sa2½ (ISO 8501-1:2007). A sharp, angular surface profile of 1.2 -3 mils is recommended.

MAJOR REFURBISHMENT

Abrasive blast clean to Sa21/2 (ISO 8501-1:2007).

Interline 104 must be applied before oxidation of the steel occurs. If oxidation does occur the entire oxidised area should be reblasted to the standard specified above.

Surface defects revealed by the blast cleaning process, should be ground, welded, or treated in the appropriate manner.

A sharp, angular surface profile of 1.2 -3 mils is recommended.

APPLICATION

Mixing Interline 104 is supplied in 2 parts, a paste component (Part A) and a liquid binder component (Part B). The

binder (Part B) should be slowly added to the paste (Part A) whilst stirring with a mechanical agitator. DO NOT ADD PASTE TO LIQUID. Material should be sieved prior to application and should be constantly agitated in the pot during spraying. Once the unit has been mixed it should be used within the working pot life. This is a low viscosity material and agitation is required during application to ensure homogeneity is maintained.

Thinner Recommended only for conventional spray application.
